## Request for Consideration of Return/Restoration of Credential

If your request for consideration is granted, the Kansas City District will initiate a process in accordance with all policies and procedures provided by the appropriate edition of the Manual of the Church of the Nazarene.

The person who surrenders his or her credential is still a member of the clergy, under discipline. The rights, privileges, and responsibilities of the clergy may be restored."
